2021 NEW JERSEY BREEDER AWARD PROGRAM

A. New Jersey Bred Pintos:

1. Any foal dropped in the State of New Jersey, except for the foals of transient mares. A mare will be considered to be a transient mare if she does not reside in the State of New Jersey for at least 120 consecutive days, including the day of foaling. The owner of a mare may be asked to submit proof of such residence to the individual breed groups.
2. Any foal resulting from an embryo transfer from a mare who resides 120 cumulative days in the State of New Jersey providing blood typing of the mare, stallion and foal is carried out in New Jersey, and embryo transfer is agreeable to the national breed registry.
3. The get of any stallion standing only in New Jersey during the breeding season of the year in which the foal was conceived. Stallions standing in New Jersey must breed only in New Jersey for that years breeding season.
4. Foals resulting from the transport of semen from a stallion standing the full season in the State of New Jersey, providing blood typing of the stallion, mare and foal are carried out to authenticate parentage and semen transport is agreeable to the national breed registry.

B. Nominated:

1. All animals must be nominated for this program. Nomination forms are provided by NJPtHA and must be filed every year. For the 2017 year there will be a \$5.00 nomination fee for Pintos wishing to participate in the NJ Bred Program.
3. Owners of nominated Pintos (all owners as listed on the registration papers) MUST be members in good standing of New Jersey Pinto Horse Association, Inc.
4. A copy of the Registration Papers (front and back) must be included with all original nominations and with all re-nominated Pintos that have changed ownership.
5. New Members- Foals of the current year and newly purchased Jersey Bred Pintos:
 - a. New members may join at any time during the year and nominate their eligible New Jersey Bred Pintos, but, no credit toward the Breeder Awards Program will be credited to animals until all membership and nomination requirements are fulfilled.
 - b. Pintos purchased by members after nomination deadlines may be nominated anytime during the year. No credit will be given to these Pintos until nomination is received. If Pinto purchased has been nominated by its previous owner, then re-nomination will be required for change of ownership, but, all points earned with previous owner will stand on Association records.
 - c. Foals of the current year can be nominated after their birth, but, must be registered and copies of their Registration Papers or Condition Registration Papers on file with the New Jersey Pinto Point Secretary before they can enter shows or earn points.

C. Qualified (to receive Breeder Award money):

1. All nominated Pintos must attend NJPtHA shows and show to at least 3 judges in ROM PtHA classes to be qualified for NJ Breeder Awards. All NJPtHA approved shows are pointed towards New Jersey Breeder Awards.

D. Show Rules for New Jersey Bred Pintos:

1. In order to be eligible to receive New Jersey Breeder Year End Awards, a member must show under three judges in a ROM class at NJPthA shows.
2. There must be a minimum of two (2) horses entered, shown and judged in a class at NJPthA approved shows for that class to earn points toward New Jersey Breeder Awards. No class of less than three (3) entries will be pointed (except for weanlings).
3. Performance (riding classes) held at NJPthA shows are for Pintos two (2) year of age and over. Foals dropped later than 2 months prior to show date will not be accepted as entries.
9. Any problems/conflicts arising from the New Jersey breeder Award Program regarding eligibility, etc. are handled by the New Jersey Pinto Board of Directors and their decision is final!
10. All New Jersey Breeder Award Program money earners and the amount of money paid per placement will be published to the membership yearly once finalized.
11. All horses will receive the same amount of money. Money will be calculated on a percentage basis. Total year end amount of money is provided by the State, and is based on the number of horses that nominate and show
